Florida Statutes Chapter 119.071(4) provides that certain individuals are exempt from disclosure of personal information set forth in the statute if the qualified individual so requests in writing. This exempted information applies only to that in the custody or control of the above agencies. This includes but is not limited to the following individuals. Indicate position held:

- Active or former law enforcement personnel; Correctional and correctional probation officers
- Department of Children and Families Services – abuse, neglect, exploitation, fraud, theft, other criminal activities investigators
- Department of Health – child abuse or neglect investigators
- Department of Revenue – revenue collection and enforcement, child support enforcement
- Firefighters
- Current or former non-sworn investigative personnel of the Department of Financial Services
- Current or former non-sworn investigative personnel of the office of financial regulations bureau of financial investigations
- Justices of the Supreme Court, district court of appeals judges, circuit court judges and county court judges
- Current or former state attorneys, assistant state attorneys, statewide prosecutors, or assistant statewide prosecutors
- General magistrates, special magistrates, judges of compensation claims, administrative law judges of the Division of Administrative Hearings, and child support enforcement hearing officers
